#### How to Comply with the Americans with Disabilities Act

This guide from the Equal Employment Opportunity Commission (EEOC) answers questions about whether restaurants and other food service employers risk violating the Americans with Disabilities Act (ADA) if they base employment decisions, such as whether to exclude an employee from the workplace, on local public health rules modeled on the FDA's Food Code. This guide assures employers that they can both follow the rules of the Food Code and comply with the ADA. The guide also explains how the ADA applies to food service employers and people with disabilities who work in restaurants.
